This is a summary of the annual report for the INTL ASSN OF HEAT & FROST INSULATORS & ALLIED WORKERS LOCAL NO. 26 ANNUITY PLAN, (Employer Identification No. 16-1339808, Plan No. 003) for the period September 1, 2019 to August 31, 2020. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$293,315. These expenses included \$113,552 in administrative expenses and \$179,763 in benefits paid to participants and beneficiaries. A total of 148 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$7,261,766 as of August 31, 2020 compared to \$6,401,320 as of September 1, 2019. During the plan year the plan experienced an increase in its net assets of \$860,446. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of \$1,153,761, including employer contributions of \$411,348, gains of \$189,367 from the sale of assets and earnings from investments of \$553,046.
